GBE brokers MT4 Booster Pack

The use of the GBE brokers MT4 Booster Pack is subject to the terms and conditions detailed below. By using the MT4 Booster Pack, you acknowledge that you have read and agreed to be bound by these terms and conditions. GBE brokers Ltd (hereinafter 'GBE brokers', 'GBE', 'us', 'our', or 'we') has made available a series of MetaTrader 4 (also referred to as 'MT4') tools available for its clients (also referred to as 'client', 'you', 'customer', 'customers', 'trader', 'traders') in the form of the MT4 Booster Pack.

1.0 Terms and Conditions

- 1.1 By accepting the MT4 Booster Pack T&Cs, the client acknowledges that he/she has read and agreed to be bound by these T&Cs as well as with the Client Agreement and all other Business terms and conditions as these may be applicable and/or amended from time to time.
- 1.2 The current terms and conditions will be the one that is posted on the GBE brokers' website.
- 1.3 GBE brokers reserve the right, as it is in its sole discretion deems fit, to alter, modify, change or terminate the MT4 Booster Pack License (hereinafter "License").

2.0 Description of the GBE brokers MT4 Booster Pack

- 2.1 GBE brokers has delivered a suite of multi-platform, multi-lingual, market-informed apps which help traders to optimise their ability to trade successfully. The apps give traders institutional quality tools over and above those provided in the underlying trading MT4 platform. This includes advanced trade execution and management, decision assistance, sophisticated alarms and messaging broadcasting facilities, plus news and market data. The apps can be branded to offer brokers a cross-platform, customised solution for traders.

3.0 The Software

- 3.1 The MT4 Booster Pack is a software package that includes various trading tools (also called 'apps') that may assist the trader when using the GBE brokers MetaTrader 4 trading platform.
- 3.2 The software trading apps are not in any way designed to guarantee a trader winning positions on MT4, and should not be used as such.
- 3.3 All the apps are 100% client-side and do not require any changes to your copy of the GBE brokers MT4 trading platform.
- 3.4 The apps are supplied with a lightweight installer which seamlessly installs the apps on your GBE brokers MT4 platform.

- 3.5 The Client agrees and acknowledges that GBE brokers will not be held responsible for any power or technical failures or any effects your computer might suffer after you have installed the MT4 Booster Pack.

4.0 Seeking Assistance

- 4.1 If you are unsure as to how to use the various tools provided in the MT4 Booster Pack, please consult the MT4 Booster Pack User Guides as well as the Video Tutorials. These can be requested from your dedicated GBE brokers Account Manager.
- 4.2 You may also ask your GBE brokers Account Manager how to use the tools within the MT4 Booster Pack, and he/ she will do their best to provide useful information on how to use the MT4 Booster Pack. Please note the advice will only be of technical nature and only in relation of how to use the MT4 Booster Pack and never of a financial nature.

5.0 Receiving and Keeping Your MT4 Booster Pack License

- 5.1 The MT4 Booster Pack is available to GBE brokers traders who already have a GBE brokers Live Trading Account and have a minimum of 2,000 EUR/USD/CHF in their account, dependent on the availability of the licenses (see point 7.2)
- 5.2 To receive a license, you need to contact your GBE brokers Account Manager and request a license. Once approved (when you have met the conditions stated above and below), you will receive the MT4 Booster Pack license.
- 5.3 If you have received the MT4 Booster Pack and your live trading account balance falls below the 2,000 EUR/USD/CHF amount, your MT4 Booster Pack license will only be revoked if you fail to trade one lot over the course of 30-days.

For Example:

Your GBE brokers Live Trading Account has a balance of \$1,460.

You trade one lot on 5th August and do not trade another lot until 11th September. Your MT4 Booster Pack license will be revoked and you will need to ensure your account has a minimum of \$2,000 in it before you can regain your MT4 Booster Pack license.

The trading volume of one lot refers to all financial instruments that are available on the GBE brokers MetaTrader 4 trading platform. These include all FX instruments such as Majors, Minors and Exotics.

Also included are all CFDs, which include Metals, Commodities, Energies, Indices and Bonds.

Terms & Conditions for GBE brokers MT4 Booster Pack

6.0 Termination

- 6.1 The MT4 Booster Pack License can be revoked/ terminated automatically at the beginning of each month if the client's account shows that there hasn't been the required amount of trading activity (as described in section 5.2)
- 6.2 The client can terminate their MT4 Booster Pack License at any time if he/ she wishes to do so.
- 6.3 Once the License has been terminated, it is down to the client to physically uninstall the application if they wish to do so.

7.0 Acceptable Policy Use

- 7.1 The following activities are not permitted when owning an MT4 Booster Pack License and even if the above conditions are met the Company can terminate the Client's access to the service and/or block the Client's account:
 - 7.1.1 Attempting to use the GBE brokers MT4 Booster Pack on another MT4 trading platform that isn't from GBE brokers.
 - 7.1.2 Attempting to hack, adjust, or reverse engineer the code.
 - 7.1.3 Selling or attempting to sell the MT4 Booster Pack.
 - 7.1.4 Any activity which has the potential to bring GBE brokers' reputation into disrepute.
 - 7.1.5 The client has abused or attempted to abuse the software and/or acted with a lack of good faith
- 7.2 The Client acknowledges there is a limited number of Licenses and he/she understands that GBE brokers will not be held liable in case the Company does not have other License to offer.

For Example:

If you have met the deposit requirement, and GBE brokers has already given out all of its MT4 Booster Pack licenses, you cannot hold GBE brokers liable.

The Client acknowledges that trading Forex and CFDs involves a high level of risk. Forex and CFDs are leveraged products and it is possible to lose all your capital. These products are not suitable for everyone and you must ensure that you understand the risks involved. GBE brokers encourages you to seek independent advice if necessary.
